

## **Families and Wealth: New Perspectives on Economic Wellbeing**

### **Overview**

Wealth is a central dimension of social stratification and vital for the economic wellbeing of individuals and their families. Wealth is important to cushion adverse life course events and to enable individuals and families to make sustainable investments in their futures within and across generations. At the same time, demographic trends such as later partnership formation and lower partnership stability affect wealth accumulation of families. In addition, these trends may create tensions between the accumulation of collective wealth in families and the economic wellbeing of their individual members.

The aim of this workshop is to bring scholars from different disciplines together to stimulate discussion and exchange of innovative perspectives on these issues from a dynamic family perspective.
